RE: Investigation Request into Chinese Government Ties to Kentucky Schools

## Dear Governor Beshear:

Our partner organization, Parents Defending Education, released an investigation on July 26 into Chinese government ties to American K-12 schools. Documents uncovered via online searches and public records requests show that thirteen public school districts and two private schools forged ties with Chinese government backed programs. The Kentucky schools included in our report are: Beechwood Independent School District, Carroll County Public Schools, Cloverport Independent School District, Fayette County Public Schools, Fleming County Public Schools, Hardin County Public Schools, Henderson County Public Schools, Jefferson County Public Schools, Louisville Collegiate School, Montgomery County Public Schools, Oldham County Public Schools, Robertson County Public Schools, Simpson County Public Schools, Francis Parker School of Louisville, and Woodford County Public Schools.

PDE Action respectfully requests the Office of the Governor of Kentucky to investigate ties between Kentucky schools and Chinese government sponsored programs. While it's vital for American students to have opportunities to learn world languages and cultures, schools should not give the Chinese government unfettered access to K-12 classrooms. This has the potential of posing significant security risks to students, families, and our national interests.

Through its Ministry of Education, the Chinese government's ties to American K-12 schools is one facet of the Chinese Communist Party's larger soft-power effort to influence policies in nations throughout the world. According to the United States Senate Permanent Subcommittee on Investigations, developing its Confucius Classroom network in the United States is a top priority for the Chinese government. They openly acknowledge this is a way to advance their strategic goals around the world. In a Chinese state media article from 2016, the Chinese Communist Party "lauded" Confucius Institutes and Confucius Classrooms for promoting its Belt and Road Initiative.

In several cases, Parents Defending Education found that university Confucius Institutes provided the foundation for Confucius Classrooms at nearby school districts. In 2020, the State Department designated

Confucius Institutes—the university counterpart of Confucius Classrooms—a "foreign mission" of the Chinese Communist Party.<sup>2</sup> As Parents Defending Education notes in its report: "Confucius Institutes are funded in part by the Chinese government under guidance from the Chinese Communist Party's United Front Work Department, 'the Chinese Communist Party's overseas propaganda and influence operation." Li Changchun, the former chairman of the Chinese Communist Party, in 2009 boasted that Confucius Institutes are "an important part of China's overseas propaganda set-up."

PDE Action hopes you will take this opportunity to review Kentucky schools' ties to the Chinese government—which is inseparable from the Chinese Communist Party. American students should not be subjected to Chinese Communist Party propaganda under the guise of Chinese language and culture programming.
